OFFICIAL TERMS & CONDITIONS

1. Organiser

This raffle is organised and conducted by the Sandton Society for the Prevention of Cruelty to Animals (Sandton SPCA), a registered non-profit organisation (NPO No: 000-713; PBO No: 930 009 645).

2. Regulatory Compliance

This raffle is conducted in accordance with approval granted by the National Lotteries Commission and in compliance with the Lotteries Act, 1997 (Act No. 57 of 1997). This raffle is registered with the National Lotteries Commission as Scheme No: 00547/01.

3. Purpose

All proceeds from the raffle will be used to support animal welfare activities including inspectorate services, rescue, veterinary care, shelter operations and community outreach.

4. Ticket Details

Ticket price: R100 per ticket

Maximum number of tickets: 1,000

Maximum gross proceeds: R100,000

Tickets sold on a first-come, first-served basis

Each ticket is uniquely numbered

5. Sales Period

01 July 2026 to 26 August 2026, or until sold out.

6. Eligibility

Open to persons aged 18 or older.

Committee members are excluded.

Staff may participate.

7. Prize

Return flights for two (Johannesburg to Durban) and a 4-night cruise on MSC Armonia 2026/2027 cruise for two adults.

Estimated value up to R20,000 depending on travel dates and availability.

Subject to supplier terms.

Not transferable or redeemable for cash.

8. Draw Details

Manual random draw under auditor oversight (BKG).

9. Winner Notification

Winner will be contacted within 30 days.

If unreachable, a redraw may occur.
